

Have shown that Robert Elliot as a witness to the estate of Arthur Alger, and listed as joining the Black Point (Scarborough) Garrison, Robert Elliot was a part of the King Philip war in the Black Point region in 1776.

¹ **Nathaniel Fryer** was born in Boston; supposed to be the son of James of Cambridge, removed to Portsmouth, and lived at Great Island. He was a rep., councillor, judge of probate, and filled many other important offices. He left two daughters, Elizabeth, who married Judge Hinckes; Sarah, married Robert Elliot. He died August 13, 1705. (See N. H. His. Coll., VIII, 353). Councillor James Fryer was his eldest son. (Wentworth Gen., I, 103). At the attack on Richmond's Island, by the Indians, in Oct. 1676, a vessel was there from Portsmouth, belonging to **Nathaniel Fryer**, sent at the request of Walter Gendall, to preserve the property on the island. The vessel was driven on shore by the enemy, and the crew of eleven taken prisoners, among them was James Fryer, son of the owner, a young man of Portsmouth, who afterwards died of the wounds received in that engagement. In Kittery, **Charles Frost** was Captain; Roger Plaisted, Lieutenant; and John Gattery, Ensign. In York, Job Alcock, Lieutenant; and Arthur Bragdon, Ensign. In Wells, John Littlefield, Lieutenant; and Francis Littlefield, Jr., Ensign. In **Scarborough**, Andrew Alger, Lieutenant. In Falmouth, George Ingersol, Lieutenant.

In the General Court held in Boston in May, 1669, there were three representatives from Yorkshire, viz.: **Charles Frost**, from Kittery; Peter Wyer (Weare), from York; and Richard Colicott, from Falmouth and **Scarborough**.

In 1670 the interior regulations of Yorkshire were completed. Thomas Danforth, an experienced assistant of ten years, was designated to preside in the County Court; and Elias Stilman, of Great Island; John and Richard Cutts, of Kittery; and three or four others in different towns





Sarah Pepperrell wife of Charles Frost⁴, was a daughter of Captain Andrew and Jane (**Eliot**) Pepperrell, and was born Dec. 14, 1708; married Sept. 12, 1723. The sister of Sarah was Margery, born March 25, 1712, who married Capt. William son of Lieut.-Gov. John Wentworth, the royalist. They were the only children of Capt. Andrew Pepperrell, the brother of Sir William. Jane **Eliot** (wife of Captain Andrew Pepperrell) was a daughter of **Robert Eliot** of New Castle, who was an eminent merchant and member of the Provincial Council of New Hampshire for many years prior to 1700 and was sister of **Robert Eliot** of Kittery, graduate of **Harvard college, 1701**. It is from this **Robert Eliot** that the town of **Eliot** takes its name, as do many of his descendants in the Leighton, Frost and connected families.

Robert **Eliot** did not utilize the same spelling as his father Robert **Elliot** with the two “l”s and also spelled it as **Ellet**, common spellings during the time in Fermanagh, this is utilizing records.

As indicated by the legal record. He it is felt the Robert Sr leaned toward the **Ellet** spelling in the Scarborough, where it is felt there would be a greater number of Scots, used for mill work along the coast. It was best to build the mills utilizing stream power, because of the strength of it, then ship products such as lumber, and ground grain from the region by boat, but these wilderness mills in the New Hampshire, and Maine, and Otter Neck utilized indentures.

One can see the name Dixon in the York County, Maine, region as being spelled Dickson Robert **Eliot**, gentleman of 1658 never existed, in 1659 it was Robert **Ellet** which became Robert **Elliot**.

When concepts are accepted as being not true then that is the beginning I want, because they still are a concept, only when they can be shown as being not true the **Harvard effect** is not in use.

ELIOT INCORPORATION PAPERS.

FRANCIS KEEFE.

As a most valuable addition to our local history, we have gathered from the archives of the State House, Boston, the Documents that relate to the Incorporation of Eliot.

The story of the "Upper Parish of Kittery," is a fascination, whether we glance backward to the scattered homes of 1621, or gather up the facts of 1810.

By the earliest Paper which we print to-day, it will be seen that Eliot became a Parish, 17 July, 1660. It became a Town, March 1, 1810.

There is a tradition that we are the namesake of the historic Eliots, whose ancestor,—ROBERT ELIOT, of Newcastle,—was a gentleman of wealth and public and social life; and whose children were blended in marriage with our own important and leading families. When the hour of our Incorporation came, the Rev'd JOHN ELIOT, of Boston, an intimate friend of Gen. Andrew Pepperell Fernald of our parish, desired that we take his family cognomen. He promised the town a meeting house bell, as the christening gift. Gen. Fernald strongly seconded and advocated his request. And so we have been called ELIOT to this day.

In regard to the bell,—no belfrey was ever builded, and so the bestowment was never made!

This is the tradition. And an interest has been quickened by our Historical Society to confirm this story of our baptism. At a later date these confirmations may be gathered into the permanancy of type.

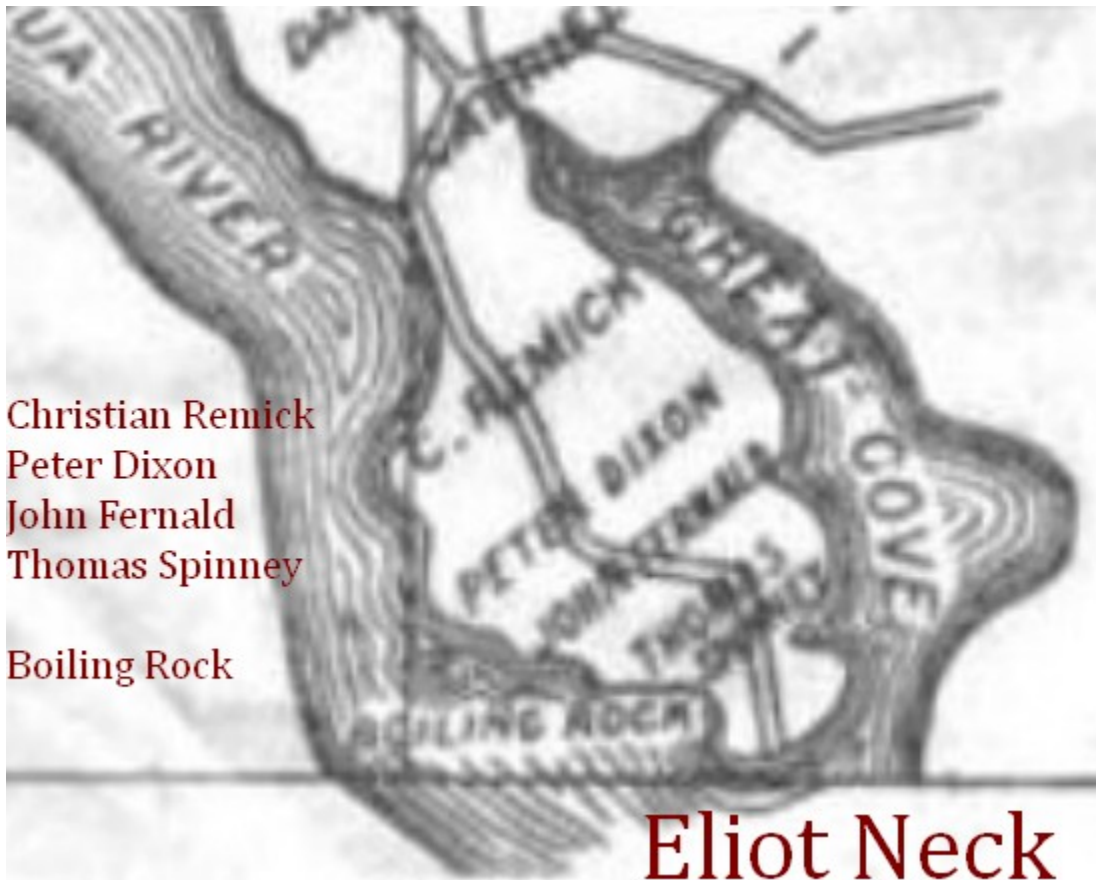

Above it should be noted that the Scottish name **Dixon** (**Nixon**) has been changed to the English spelling of **Dickson** in a similar manner **Ellot** was changed to **Elliot** then to **Eliot**. The neck of land was know as **Eliot Neck** way before the town of **Eliot** existed, and it is felt that people traveling up river from **Kittery** would go through **Eliot Neck** to get to **Eliot**, and **Eliot Neck** is on the border of **Kittery** and **Eliot**.



John Green, Humphrey Axel his brother-in-law, and Mary [Green] Axel wife of Humphrey, migrated to South Carolina. And they sold their father's [John Green,] lands at this point of our River. Let us glean the story from the books, 1704-5:—

“ I John Green of South Caralina, planter, the Son and heir of John Green of Kittery, Together with us Humphrey Axall and Mary his wife, Set over unto Peter Dickson One Lot of Land near the boyling Rock containing thirteen Acres, bounded on the west with ye River of Piscataqua ; by the Land of Christian Remock on the North ; on the Land of Peter Dickson and Thomas ffernald on ye South ; and on ye land of Peter Dickson on the East.”

They sell Peter Dickson another lot at another point, still known by its early name—Bolt Hill—and we have not found an earlier allusion to this local name :

“ One piece of Land at a place called bolt hill, bounded on the land of Steuen Paul on the west; ; on ye east on ye land of John Spinney ; on Waymouth Lisson land on the North west ; on Land comonly called Cutts Land on the North. And on ye Land of John Thomas on ye South

In 1704-5, March 4, Peter Dickson sold these Bolt Hill acres to John Staples.

We also find another record, dated—

South Carrolina, Jan. 29, 1704-5. We John Green, Humphrey Axell and Mary his wife, have ordained appointed and constituted our well-beloved friend, Mr. Peter Dickson, to be our true and Lawfull Attorney for and in our name as Joyntly and Severally to act for us or either of us.”

Thus have we taken a historic walk on our River’s rim; and before we bring the review of the early homesteads to an end, we would like to turn our faces again to the Long Reach households of the Tobeys, Libbeys, Foggs and Hammonds, or as they are called,—Hammond & Co.—There is one more and an earlier proprietorship of that stretch of land which gives an antiquarian relish, a breath of romance to that section.

In 1685 Humphrey Elliot, et ux (and wife which is the step daughter of Champernowne), half of Champernown's Island (now Gerrish Island, after Timothy Gerrish son-in-law to Robert Sr). The Robert **Eliot** spelling is rare in the deeds for Robert Sr, and likely not the way Robert Sr spelled it, as can be seen **Elliot (Eliot)** where **Eliot** is a spelling correction by the transcriber.

¹The records of the church in Boston show that on the seventeenth day of the tenth month, 1681, a little more than six months after the baptism of her daughter Bridget, wife of **William Screven**, Mrs. Mary Cutts, widow of Robert Cutts (who died the last of June, 1674), was baptized in Boston and united with the Baptist church in Boston. On the same day Leonard Drowne of **Kittery** was baptized. Five additional residents of **Kittery**, viz., George Litten, Timothy Davis, Wm. Addams, Humphrey Axall and John Morgradge were baptized and received as members of the Baptist church in Boston on the twentieth day of the twelfth month, 1681. In July, 1682, four others, ——— Landall, Richard Cutts, Sarah Morgandy and Robert Williams of **Kittery** were baptized and received to membership in the Boston church. Richard Cutts was the oldest son of Robert and Mary Cutts, and a brother of Mrs. Screven. Sarah Morgandy—so the name seems to be written—was probably the wife of John Morgradge, as the same spelling, Morgandy, occurs in Backus' list of the constituent members of the church, while in the Boston records his name is plainly recorded as John Morgradge.

WE whose names are under written by complaint and request of some of the Inhabitants of the neck of Land lying in the lower part of the long Reach, also by a vote past at a general town Meeting held at Kittery, March 18th, 1694-5 for laying out a highway for the convenience of the inhabitants and benefit of the Town and Country, have viewed and laid out a highway of two Rods wide, where the land will afford it, from the Country road behind Stephen Paul's to Peter Dixon's, running from Mr. Remick's fence along by Humphrey Axel's orchard, in that highway we have had lately, which the said Humphrey hath lately fenced in, and so the highway to run from Peter Dixon's to Samuel Fernald's, one rod wide from the Bank as straight as may be with convenience, and ail to run by the River-side.
